# 8. PLANNING AND ENVIRONMENT COMMITTEE – 2nd APRIL, 2013

<u>Minute 75(b) – Car Parking Issues – Lower Section of Alice Road</u> – In response to a question from a Member the Town Clerk confirmed that a response had been received from Dorset County Council which would be reported to the next meeting of the Planning and Environment Committee.

Minute 77 – Dorchester Transport and Environment Plan – In response to a question from a Member the Town Clerk stated that a special meeting of the Planning and Environment Committee would only be arranged when there was something new to discuss about the Dorchester Transport Environment Plan.

<u>Minute 80 – A-Boards</u> – In response to a question the Town Clerk confirmed that he had circulated the information on the outcome of Dorset County Council's Cabinet considerations in respect of the issue of A-Boards in the town centre. ### 10. PLANNING AND ENVIRONMENT COMMITTEE – 29th APRIL, 2013

It was proposed and seconded that the Minutes of the Planning and Environment Committee held on 29th April, 2013 be adopted.

<u>Minute 82 – Queen Mother Square</u> – Members asked that the Duchy of Cornwall be requested to provide further information regarding whether or not the traffic issues previously identified would be likely to be helped when the surface finishes had been applied to the shared space at Queen Mother Square and what the likely timescale was for the completion of works in this area.

Minute 85(a) – Dorset County Council – 20mph Areas – Members expressed their dismay at the response from Dorset County Council regarding the implementation of 20mph speed restrictions. It was reported that the guide produced by a partnership led by the Royal Society for the Prevention of Accidents entitled Road Safety: A Guide for Local Councillors in England clearly stated that 20mph schemes not only reduced the risk of crashes, but also pedestrians had a much greater chance of surviving if they were hit by a vehicle at 20mph or less, rather than 30mph. Members wished to know why Dorset County Council appeared unaware of the guide and why the Town Council had received such tendentious correspondence from the County Council which had stated that a 20mph speed limit would not always reduce collisions and the impact of collisions. The Town Clerk confirmed that additional information on this matter would be provided at the next meeting of the Planning and Environment Committee but that no officer from the County Council would be in attendance. It was also reported that the introduction of 20mph areas did increase the level of road pollution.

<u>Minute 86 – Stop the Drop</u> – It was reported that future activities of Dorchester Stop The Drop would be managed through the Dorchester Area Community Partnership group and Members agreed that the Council should no longer appoint a representative to the group.

#### **RESOLVED**

- (1) That the Duchy of Cornwall be requested to provide comment on the likelihood of the traffic issues previously identified being resolved when the surface finishes had been applied to the shared space at Queen Mother Square and on the anticipated timescale for the carrying out of this work.
- (2) That Dorset County Council be informed of the publication 'Road Safety: A Guide for Local Councillors in England' and requested to explain why it had not taken notice of the

information provided in that guide in the response sent to the Town Council.

(3) That the Minutes of the Meeting of the Planning and Environment Committee held on 29th April, 2013 be adopted.

# 11. MANAGEMENT COMMITTEE – 7th MAY, 2013

It was proposed and seconded that the Minutes of the Management Committee held on 7th May, 2013 be adopted.

Minute 81 – King's Road Playing Field – Arising from the consideration of this Minute the Mayor informed Members that a narrow footpath was being created along the river bank on the opposite side of the river to King's Road Playing Field. The path would be delineated by a wire fence and behind that there would be a barbed wire fence so as to contain cattle which were to be grazed in the field.

Minute 82 – Future Maintenance Arrangements for Fordington Fields and Max Gate Roundabouts – The Chairman of the Committee informed Members that himself, the Mayor and the Deputy Town Clerk had met with the officer from Dorset County Council responsible for the roundabout sponsorship initiative who had stated that he was content for the Town Council to continue maintaining the roundabouts at its own expense and that if this was agreed the sponsorship signs would be amended to say 'In Partnership with Dorchester Town Council'. Future maintenance of the roundabouts would be discussed again at the next meeting of the Management Committee. It was noted that some maintenance work had been undertaken by the County Council to the Fordington Fields roundabout.
