Planning and Environment Committee – 4 January 2016 Minute Update Report

1. Minute 112/15 (3 August 2015)

Dorchester Prison Site

West Dorset District Council has now received a full planning application for the Dorchester Prison site from City & Country and the Town Clerk, the Committee Clerk and the Chairman of the Planning and Environment Committee have discussed the process for considering and making the Town Council's representation.

City & Country have been requested to initially brief all Councillors on the full planning application during January 2016. Then a special meeting of the Planning and Environment Committee will be called to consider this single planning application and this meeting will provide the opportunity for members of the public to present their views to the Town Council.

2. Minute 113/15 (3 August 2015)

Dorchester Parking Review

Dorset County Council have undertaken a public consultation regarding various new parking restrictions proposed for Dorchester. The Town Council considered these proposals at the meeting of the Planning and Environment Committee on 8 August 2015 and apart from a couple of minor amendments to the proposals for Alfred/Cromwell Roads and Williams Avenue, the Committee supported the Traffic Regulation Order.

The next stage of the process is for DCC's Regulatory Committee to consider the representations received and officers' recommendations as to action to be taken on introducing any new parking restrictions (meeting is on 28 January 2016).

One particular issue to note is that, following representations made by a Dorchester County Councillor in the light of public comments, the Coburg Road/Edward Road proposals will be looked at again and dealt with separately in the new year.

3. Minute 138/15 (30 November 2015)

Minute Update Report – Bollards in New Street

DCC have been asked to install a traffic tube at the junction of New Street and South Street for a week to collect data on the actual traffic using this junction when the TRO times are in force and they are considering the Town Council's request.

4. Minute 141/15 (30 November 2015)

Requests for New Parking Restrictions

The Town Clerk and Committee Clerk had a meeting with a member of DCC's Highways team to discuss the current Dorchester Traffic Regulation Order and were advised that the whole county budget for TRO's for 2015/16 has been £50,000. Additionally, as TRO work has been undertaken in Dorchester during this financial year, it is unlikely that Dorchester will be looked at again until 2017/18.

1. 9 PLASSEY CLOSE, DORCHESTER, DT1 2PR WD/D/15/001744

Erect two one bedroom new build flats within the side grounds with a communal refuse area Planning application withdrawn on 1 December 2015.

Dorchester Town Council comment: No objection.

County Highway Authority comment: The County Highway Authority recommends refusal on the following grounds:- The proposal lacks any designated parking provision and is an area already subject to high on-street parking demands so it would be likely that vehicles associated with the premises would be parked on the adjoining highway which would prejudice the free flow of traffic and conditions of general safety on the adjoining road network.

2. 3 HIGH WEST STREET, DORCHESTER, DT1 1UH WD/D/15/002129

1 no. fascia externally illuminated sign and 1 no. externally illuminated projecting sign. Dorchester Conservation Area

Planning application approved by West Dorset District Council on 21 December 2015. Dorchester Town Council comment: Recommend refusal. The application is contrary to the Town Council's policy on internally illuminated shop signage in High West Street.
