# Reports of Speeding at Kings Road, Dorchester

Dorchester Town Council has received the following query:

"We have recently moved into a house on Kings Road in Dorchester.

We are new to this area but have been networking with neighbours and the local people, and they all agree that the speeding on the road is out of control.

We are opposite a children's park, there are a lot of pedestrians and children who walk on this road, and also there are houses with front gates lead directly onto the road.

The traffic yes, is busy and we understand peak traffic times we have to endure. But it's the mindless speeding at night and in quieter times of day that are extremely dangerous. We would hate not to raise awareness with yourself and god forbid, an accident were to happen.

Please can you advise on what as a community, we can do to try and get restrictions in place such as a speed camera? We understand and we are near to an ambulance station, so speed bumps are probably not an option.

Just your advice on what we all need to do to campaign for the safety of this road, would be very much appreciated."

The Dorset Council Road Safety Officer has been contacted to see if the location would be suitable for a Speed Indicator Device (SID), He has said:

"The last speed survey undertaken on this road was just under required criteria, so you could request another survey if you want? The other options are to report to Dorset Police the excessive speeding as this is an enforcement, not SID matter."
